# FCC Implements "Red Light Rule" for Those Owing It Money

September 26<sup>th</sup>, 2004

#### ARRL

Effective Friday, October 1, the FCC begins implementing new rules that bar anyone who is delinquent in debts owed to the Commission "from receiving a license or other benefit until the delinquency has been resolved." The so-called "red light rule" represents further implementation of the Debt Collection Improvement Act of 1996.

The new rule will have an impact on anyone doing business with the FCC who owes money to the agency, and it affects anyone filing an application or seeking a benefit from the Commission or one of its components.

Under the red light rule, when someone files an application or request for benefit, the Commission will check the applicant's FCC Registration Number (FRN) to determine if the entity or person is delinquent in a debt owed the Commission. "Multiple FRNs associated with a Taxpayer Identification Number (TIN) will be included in the red light check," the FCC said, "and if the TIN is found to have delinquent debt, your application will receive a red light." Delinquent debtors

have 30 days to either pay the debt or make other satisfactory arrangements. Otherwise, the application will be dismissed.

Additionally, the Commission has amended its fee rules consistent with the new red light rule. All application fees now must be paid in full prior to an application grant. Under past FCC business practice, when an application underpaid the fee, the application was processed and the applicant billed for the additional amount.
